Some duplication among the 3 reels of microfilm and the documents has occurred because of the different sources of loan.

Note to the researcher:

For the following NAACP files, 1948-1957 and undated, series types are recorded for each folder, including date spans. The material has been kept in the original folder groupings in which they were received from the Attorney General's Office. However, these folder groupings were often unlabelled, thus necessitating description primarily by series types. Within the folder, material is arranged chronologically by series.

A small portion of the material received from the Attorney General's Office which was illegible was removed. Material which was marginally legible was retained for inclusion.

The first two reels are identical, except that one is negative microfilm and the other is positive microfilm. Some negative photostats that are illegible on the positive microfilm are legible on the negative microfilm.
